## New ConTex-Commentary - issued:

This week the New ConTex dropped by 7 points ( - 1.1 %). But let's try to be positive :


Despite depressed freight rates on a number of key routes (FAR EAST – Europe & FAR EAST - USWC), fast rising oil prices, bearish economic figures in several major nations and a growing overcapacity, the market is in fact proving resilient, and dropping only moderately.

Although at its lowest level since December 2020 the market is still 30 percent higher than in December 2019, before the world was hit by the Covid pandemic and container shipping entered a two-year period of exceptional financial.

One of the main reasons why the market remains is the continued low supply of ships, especially in the larger sizes above 3,000 teu. The rare available vessels in these segments usually get fixed quickly at healthy rates, even more so for the latest generation of energy-efficient tonnage.

Below 3,000 teu, the picture is somewhat different with oversupply impacting the 1,500-1,900 teu and the 500-1,200 teu sizes quite significantly. As a result, charter rates in these sizes are under pressure
